## CHANGE IN NOMENCLATURE OF CRISIL INDICES / BENCHMARK FOR VARIOUS SCHEMES OF THE FUND

NOTICE is hereby given that pursuant to SEBI Circular No SEBI/HO/IMD/IMD-II DF3/P/CIR/2021/652 dated October 27, 2021, on "Guiding Principles for bringing uniformity in Benchmarks of Mutual Fund Schemes", AMFI has published the list of CRISIL Indices as per Potential Risk Class (PRC) to be adopted by AMCs. Further in this regard, AMFI vide its email dated March 15, 2023, has communicated the change in nomenclature of CRISIL Indices that shall be effective April 03, 2023. Investors may please note that while the construct and composition of the Index remains the same; only the nomenclature has changed.

Accordingly, the revised names of CRISIL Indices for the below schemes of TRUST MUTUAL FUND shall be:
