Notice-cum-Addendum to the Scheme Information Document ("SID") and Key Information Memorandum ("KIM") of the Schemes of Trust Mutual Fund ("the Fund")

Investors are requested to note that this addendum sets out the following changes to be made in the SID and KIM of the below mentioned scheme(s) of the Fund.

CHANGE IN TIER – I BENCHMARK AS PER POTENTIAL RISK CLASS FOR SCHEMES OF THE FUND

Pursuant to SEBI Circular No SEBI/HO/IMD/IMD-II DF3/P/CIR/2021/652 dated October 27, 2021 on "Guiding Principles for bringing uniformity in Benchmarks of Mutual Fund Schemes", SEBI had advised AMFI to publish the list of Tier – I benchmarks as per Potential Risk Class (PRC) to be adopted by AMCs.

AMFI vide its email dated March 31, 2022 has provided the list of Tier I benchmarks for open ended debt schemes as per the Potential Risk Class (PRC) matrix and the same shall be effective April 01, 2022.

Accordingly, the Tier – I Benchmark for the below schemes of TRUST MUTUAL FUND shall change effective April 01, 2022.

Pursuant to the above, all references with respect to Tier I Benchmark in the SID, KIM and SAI shall be construed accordingly. Investors may please note that the Tier I Benchmark for TRUSTMF Banking & PSU Debt Fund remains unchanged.
