Notice cum Addendum No. 16/2024

Notice-cum-Addendum to the Scheme Information Document ("SID") and Key Information Memorandum ("KIM") of certain Schemes of Trust Mutual Fund ("the Fund")

Investors are requested to note that this addendum sets out the following additions/changes to be made in the SID and KIM of the below mentioned scheme(s) of the Fund.

CHANGE IN TIER - I BENCHMARK FOR CERTAIN SCHEMES OF THE FUND

Pursuant to Para 1.9.3. of the SEBI Master Circular for Mutual Funds dated May 19, 2023 related to 'Guiding Principles for bringing uniformity in Benchmarks of Mutual Fund Schemes' read with SEBI letter dated December 14, 2023, the Tier-I benchmark to be followed by all open ended debt oriented mutual fund schemes (except credit risk funds) shall be based on the Potential Risk Class (PRC) framework of Class A in terms of Credit Risk Value and Class I/ Class II/ Class III in terms of the Macaulay Duration risk.

Further as advised by SEBI, AMFI vide its email dated February 13, 2024 has prescribed the list of PRC matrix-based Tier-I benchmarks to be adopted in this regard.

Accordingly, the PRC matrix-based Tier-I benchmarks for the below schemes of TRUST MUTUAL FUND shall stand revised w.e.f. March 12, 2024:

3	TRUSTMF Banking & PSU Fund (An open-ended debt scheme predominantly investing in debt instruments of Banks, Public Sector Undertakings, Public Financial Institutions and Municipal Bonds. A relatively high interest rate risk and relatively low credit risk.)	CRISIL Banking and PSU Debt Index	CRISIL Banking and PSU Debt A-II Index

Accordingly, the SID and KIM of the abovementioned Schemes shall be suitably amended to reflect the stated changes. This notice-cum-addendum forms an integral part of the SID and KIM of the abovementioned Schemes. All the other terms and conditions of SID and KIM of the abovementioned Schemes remain unchanged.
