2. In case of companies and partnerships, PAN of the entity is mandatory. In case of other entities, Form 60 may be obtained if PAN is not available.

#### B. Clarification / Guidelines on filling 'Proof of Identity [POI)' section

- Activity Proof -1 and Activity Proof -2 are applicable for accounts in case of proprietorship firms. Please refer to relevant instructions issued by the Reserve Bank of India in this regard.
- ii. Please refer to the relevant instructions issued by the regulator regarding applicable documents for the legal entity.
- iii. Certified copy of document or equivalent e-document or OVD obtained through Digital KYC process to be submitted.
- iv. 'Equivalent e-document' means an electronic equivalent of a document, issued by the issuing authority of such document with its valid digital signature including documents issued to the digital locker account of the client as per rule 9 of the Information Technology (Preservation and Retention of Information by Intermediaries Providing Digital Locker Facilities) Rules, 2016.
- v. 'Digital KYC process' has to be carried out as stipulated in the PML Rules, 2005.
- vi. KYC requirements for Foreign Portfolio Investors (FPIs) will be as specified by the concerned regulator from time to time.

#### C. Clarification/Guidelines for filling Proof of Address (PoA)' section

- i. State/U.T Code and Pin/Post Code will not be mandatory for overseas addresses.
- ii. Certified copy of document or equivalent e-document to be submitted.

#### D. Clarification/Guidelines for filling 'Contact Details' section

- i. Please mention two-digit 'country code and 10 digit mobile number (e.g. for Indian mobile number mention 91-999999999).
- ii. Do not add '0' in the beginning of Mobile number.

#### E. Clarification/Guidelines for filling 'Related Person Details' section

- i. Personal Details
  - The name should match the name as mentioned in the Proof of Identity submitted failing which the application is liable to be rejected.
- ii. Proof of Address [PoA]
  - · PoA to be submitted only if the submitted Pol does not have an address or address as per Pol is invalid or not in force.
  - State/U.T Code and PIN/Post Code will not be mandatory for Overseas addresses.
  - In case of deemed PoA such as utility bill, the document need not be uploaded on CKYCR
- iii. If KYC number of Related Person is available, no other details except 'Person Type' and 'Name of the Related' are required.
- iv. Regulated Entity (RE) shall redact (first 8 digits) of the Aadhaar number from Aadhaar related data and documents such as proof of possession of Aadhaar, while uploading on CKYCR.

#### F. Provision for capturing signature of multiple authorised persons is to be made by the RE.

#### G. List of people authorized to attest the documents after verification with the originals:

- i. Authorised officials of Asset Management Companies (AMC).
- ii. Authorised officials of Registrar & Transfer Agent (R&T) acting on behalf of the AMC.
- iii. KYD compliant mutual fund distributors.
- iv. Notary Public, Gazetted Officer, Manager of a Scheduled Commercial/Co-operative Bank or Multinational Foreign Banks (Name, Designation & Seal should be affixed on the copy).
- v. In case of NRIs, authorized officials of overseas branches of Scheduled Commercial Banks registered in India, Notary Public, Court Magistrate, Judge, Indian Embassy/Consulate General in the country where the client resides are permitted to attest the documents.
- vi. Government authorised officials who are empowered to issue Apostille Certificates.

#### General instructions:

- 1. Self-Certification of documents is mandatory.
- 2. Copies of all documents that are submitted need to be compulsorily self-attested by the applicant and accompanied by originals for verification.
